Happy New Year!

The Steering Committee held our first quarterly meeting in Toronto on Wednesday, January 14, 2015. Updates and highlights of our discussion are below.

Governance Transition

As agreed at the November 2014 AGM, and based on consultation with DFATD and legal advice, we believe the best way forward to stabilize the Canadian Network, and ensure its sustainability, transparent governance structures and sound human resources is to incorporate as a Not-for-Profit Organization. The legal process is underway and will be completed this spring. Upon incorporation as a Not-For-Profit, the Steering Committee will transition to an interim Board of Directors. Bylaws will be ratified and an election of the first official Board will be held during the next AGM on **November 4, 2015**.

External Evaluation of the Muskoka Initiative Project

An external agency will be undertaking an evaluation of DFATD's Muskoka Initiative for Maternal, Newborn and Child Health over the next 60 days. CAN-MNCH has been approached by the external consultants to participate and host a workshop which we have agreed to do. More information can be found here.

Strategic Planning

The key focus of the first Steering Committee meeting was to plan strategically for the next five years. Notes are below.

- What is the unique value contribution a network like this can make beyond simply being called a network?
- DFATD has invited the Canadian Network to submit a proposal for funding from 2015-2020 and this will represent a significant part of our work in the coming months.
- The Canadian Network will continue to focus on its core pillars of Measuring Results, Sharing Knowledge, and Stakeholder Engagement.
- A key focus of this year's activities will be accountability to continue to advance Canadian Partner's capacity to track common indicators and to measure results, in

- alignment with global efforts. We will expand our capacity to track outcome measures by our members and provide comparability.
- The Secretariat will expand to accommodate our mission, while remaining committed to a lean structure with high levels of engagement from Canadian Network Partners.
- The Steering Committee is exploring Network membership criteria including a fee based model as well as qualitative contributions, in order to ensure that organizations involved in the Network are participating optimally.
- As part of our transition to stronger governance and management oversight, we are putting in place a performance system and other HR processes.
