

02 Introduction to IATI and its data

Where did IATI come from?

- Many new players in the development cooperation space: not only governments, but multilateral
 organizations, civil society, the private sector, foundations and others.
- Need for a way to **capture information from non-resident partners**, or partners who did not have a formal reporting relationship with the government (e.g. to complement information available in AIMS).
- With so many partners, there was / is a need for comprehensive data on development (and humanitarian) activities to:
 - Ensure adequate information is available for budgeting, planning, and to inform allocation of national resources;
 - Reduce duplication in delivery of development activities; and
 - Ensure accountability and transparency in the delivery of activities.

Political commitment made in 2008 in Accra for development partners to provide more timely and forward-looking, open, and transparent information on their activities. IATI was born!

What is IATI?

A global initiative to improve the transparency of development and humanitarian resources and their results to address poverty and crises





Understanding the data

Data source 1,500+ organizations that publish data to IATI

Data updates
Refreshed every 3 hours

Data availability Dependent on timeliness and completeness of data published

- Timeliness = varies; data gaps could be due to data not yet being published
- Completeness = not all fields are mandatory, which means that not all organizations publish data in all data fields

Calculating "spending": Aggregate Disbursement and Expenditure transactions



What are some of the advantages of IATI data?

Detail: the data is rich and, depending on the publisher, contains data not only on finances, but (depending on the publisher) also results, the locations of projects, and project documentation.

Standardized data: all the data is in a standard and comparable format, making it possible to view and use data from a range of different publishers.

Frequency: IATI publishers generally release their data much more frequently than via other sources. This means the data is more likely to be up to date and useful.

Planned spending: projects in the planning stage can be published, and many organizations publish their forward spending plans.



What are some of the limitations of IATI data?

Quality: there's a lot of very rich and detailed information; but it's up to each publisher to decide what to release and when.


Frequency: while many large publishers publish each month, some update their data much more infrequently.

Complexity: just as development cooperation is complex, so is the data. We are gradually improving tools to access the data and welcome your feedback on them.

Double-counting: multiple organizations down the delivery chain can publish projects from their own perspective. That means you get a lot of detail, but as in the real world, there is also double-counting.

Different approaches: although the data is standardized, different publishers might publish data slightly differently, reflecting differences in their business models.

How can IATI data be accessed?

d-portal



- Recommended for viewing all information on an individual activity
- Enables searching for particular activities or sets of activities using filters and keywords

Country Development Finance Data



- Designed to meet the needs of partner country governments /
 CSOs and other country-level stakeholders
- Recommended for analysis
- Provides access to Excel-formatted data on projections and spending by country / region and data dashboards



What can IATI data tell us?

Projections:


What resources can it be expected will be spent in the country?

 How much money do organizations project that they will spend in each quarter of the next 3 years?

Spending:

What resources have actually been spent in the country?

 How much money was spent by organizations in each quarter of the fiscal year?



- What organizations are providing these resources?
- What activities are these resources spent on?
- Which sectors do the activities target?
- What modality and finance type are used to deliver these resources?
- Which organizations are the recipients of these resources?
- In what locations in the country are these activities being implemented?
- In some cases, what results did this activity achieve?

A note on results data...

- Results in IATI are generally one of three types, dependent on the publisher and unique activity:
- Output: A direct consequence of the activity, e.g. vaccinations delivered to X number of children.
- Outcome: A short term effect the activity has contributed to, e.g. lower rates of infection after a vaccination program.
- o Impact: A long term effect the activity has contributed to, e.g. improved life expectancy.
- Indicators with numerical or descriptive measures and results documents may also be reported.

However...

- There is no standardized way of reporting results in IATI.
- Reporting results is not mandatory for publishers.

Why is IATI data relevant for civil society?

ACCOUNTABILITY: provide feedback on whether particular projects are working successfully or not, and make sure resources are spent as planned.

EVIDENCE-BASED ADVOCACY: see what donors are funding and make the case for a different allocation of resources (e.g.: more funding for health or education, or more funding for a particular country, region).

COORDINATION: understand which other organizations are working in similar sectors or locations, in order to work more efficiently and effectively; or tailor your own projects.

RESEARCH: to inform policy, advocacy, etc.; e.g. uncovering expenditure issues or better understanding the actions and priorities of donors, governments and civil society organizations in different countries.

FUNDING: see which organizations are active in your country / region / sector and which organizations they fund, making it possible to discover possible funding opportunities.

Why is IATI data relevant for civil society?

Using IATI data, a CNN investigation found that some Western governments who pledged to support LGBTQI+ rights have also funded supporters of a controversial bill in Ghana that could introduce harsh sentences for advocating for sexual and gender minorities' rights.

ADVOCACY:

see what donors are funding and make the case for a different allocation of resources (e.g.: more funding for health or education, or more funding for a particular country, region).



Save the Children UK used IATI data to look at the impact of UK aid cuts, finding that children are bearing the brunt of the cuts.

COORDINATION:

understand which other organizations are working in similar sectors or locations, in order to work more efficiently and effectively; or tailor your own projects.



SEBI Livestock developed its Livestock Project Portal to enable improved coordination in the livestock sector.

Why is IATI data relevant for civil society?

RESEARCH:

to inform policy, advocacy, etc.; e.g. uncovering expenditure issues or better understanding the actions and priorities of donors, governments and civil society organizations in different countries.




Georgetown University's
Department of International Health
used IATI data to assess funding for
mental health in the COVID-19
response. They found that a very
small dollar amount of this funding
was directed to mental health causes.

FUNDING:

see which organizations are active in your country / region / sector and which organizations they fund, making it possible to discover possible funding opportunities.

World Vision®

World Vision UK uses IATI data to see who the main funders are in its priority countries. They also look at planned spending by sector to see where new funding opportunities might arise.






